- 1. FORM MVR-27PP-A MUST BE SUBMITTED TO THE ORGANIZATION PRIOR TO FEBRUARY 1, 2018. THIS SHOULD INCLUDE THE ADDITIONAL PROPOSED FEE FOR THE PLATE TO BE CONSIDERED FOR LEGISLATIVE APPROVAL.
2. IF THE PLATE IS NOT AUTHORIZED BY LEGISLATION, DMV WILL REFUND THE FEES COLLECTED TO THE ORGANIZATION. NC ASSOCIATION OF SOIL & WATER CONSERVATION DISTRICTS WILL THEN REFUND TO APPLICANT.

ANY REFUND REQUESTS MADE BY POTENTIAL PURCHASERS IS THE RESPONSIBILITY OF THE NC ASSOCIATION OF SOIL & WATER CONSERVATION DISTRICTS, NOT THE NCDMV.
